



**PROPERTY OWNERS ACKNOWLEDGEMENT OF SWIMMING POOL REQUIREMENTS
ABOVE-GROUND POOL REQUIREMENTS**

1. PROPERTY OWNER SHALL NOT ALLOW ANY WORK TO BEGIN UNTIL POOL PERMIT HAS BEEN APPROVED AND ISSUED BY THE CITY OF OLIVE BRANCH BUILDING DEPARTMENT.
2. POOL LOCATION:
 - A MINIMUM OF 10 FEET FROM MAIN STRUCTURE (THIS CAN BE LESS IN SPECIAL CIRCUMSTANCES AFTER A SITE INSPECTION IS MADE AND APPROVED BY THE CITY OF OLIVE BRANCH BUILDING DEPARTMENT INSPECTOR)
 - A MINIMUM OF 5 FEET FROM EACH SIDE PROPERTY LINE
 - A MINIMUM OF 10 FEET FROM REAR PROPERTY LINE
3. BARRIER REQUIREMENTS:
 - ALL TYPES OF BARRIERS SHALL BE CONSTRUCTED TO MEET ALL CODE REQUIREMENTS
 - ALL BARRIERS WITH PEDESTRAIN GATES SHALL BE EQUIPPED WITH A SELF-CLOSING AND SELF-LATCHING DEVICE
 - ALL BARRIERS WITH DOUBLE GATES SHALL HAVE A PADLOCK IN PLACE ON THE GATES.

NOTE: IF A BARRIER IS NOT IN PLACE AT THE TIME THE POOL IS BEING INSTALLED, TO INSURE LIFE AND SAFETY AT THE JOB SITE, A TEMPORARY BARRIER MEETING ALL CODE REQUIREMENTS SHALL BE PUT IN PLACE AND MAINTAINED AT ALL TIMES DURING THE INSTALLATION OF THE POOL.

NOTE: WHEN THE REAR OF HOUSE IS USED AS PART OF THE REQUIRED BARRIER, ALL DOORS LEAVING THE HOUSE INTO THE POOL AREA SHALL HAVE AN APPROVED UL 2017 ALARM ON THOSE DOORS.

SPECIAL NOTE: IF THE ABOVE GROUND POOL IS 4 FEET IN HEIGHT OR MORE AT FINISHED GRADE ALL AROUND POOL, MEASURED 5 FEET FROM POOLS EDGE, NUMBER 3 LISTED ABOVE WILL NOT APPLY IF POOL IS EQUIPPED WITH A REMOVABLE LADDER OR LADDER THAT CAN BE FOLDED UP AND LOCKED.

4. **YOU WILL BE REQUIRED TO HAVE A LICENSED ELECTRICIAN PULL A SEPARATE PERMIT FOR THE ELECTRICAL COMPONENTS. TAPPING OF THE ELECTRICAL METER CAN FOR POWER TO ALL POOL EQUIPMENT IS STRICTLY PROHIBITED BY NORTH CENTRAL POWER ASSOCIATION.**
5. **YOU MUST CALL FOR A FINAL INSPECTION!!! A FINAL INSPECTION BY THE CITY OF OLIVE BRANCH BUILDING DEPARTMENT MUST BE PERFORMED AND APPROVED BEFORE ANY USE OF THE POOL. AT THIS FINAL INSPECTION ALL OF THE REQUIREMENTS LISTED ABOVE SHALL BE IN PLACE AND APPROVED BY THE CITY OF OLIVE BRANCH BUILDING DEPARTMENT INSPECTOR.**
